The RumHaven and Hannah Godwin Crash Your Tuesday Night Premiere Party-Virtually Sweepstakes (the "Sweepstakes") will commence at 12:00:00 AM Pacific Time ("PT") September 22, 2020 ("Start Date") and end at 11:59:59 PM PT on October 7, 2020 ("End Date"). The period between the Start Date and End Date will be referred to as the ("Sweepstakes Period").
