

RumHaven November/December 2020 Sweepstakes
Official Rules

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

The RumHaven November/December 2020 Sweepstakes (the “Sweepstakes”) will commence at 10:00:00 AM Pacific Time (“PT”) on November 16, 2020 (“Start Date”) and end at 9:59:59 AM PT on December 21, 2020 (“End Date”). The period between the Start Date and End Date will be referred to as the (“Sweepstakes Period”). The Sweepstakes Period will be broken out into five (5) separate entry pools, as set forth in the Entry Pool & Prize Chart in Section 3 below (each, an “Entry Pool”). Entries submitted outside of the Entry Pool dates and times, including past the expiration of the final Entry Pool date, will not be accepted and will be destroyed.

- 1. SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. Gallo Winery, 600 Yosemite Blvd., Modesto, CA 95354 (“Sponsor”). The Sweepstakes is administered by Moosylvania, 7303 Marietta Ave, Maplewood, MO. 63143 (“Administrator”), for Sponsor’s RumHaven brand (“Brand”).
- 2. ELIGIBILITY REQUIREMENTS.** The Sweepstakes is open to legal residents of the United States (excluding Utah) and the District of Columbia who are 21 years of age or older. VOID IN UTAH, PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW. Directors, officers, employees, and agents of Sponsor, Administrator and any retail licensees, authorized licensees, wholesale licensees, distributors, and each of their respective parent, sister, affiliates, subsidiaries, advertising and promotional agencies, and all other corporations, partnerships, or other legal entities or individuals associated with the development, administration, or fulfillment of this Sweepstakes, and the immediate families of such persons (defined as spouse, child, sibling, parent, son-in-law, daughter-in-law, grandparent, so-called “step” or “half” variations of any of the preceding individuals, and all descendants and each of their respective spouses, regardless of where they live), and those living in their same households, whether or not related, are ineligible to enter, win or collect prizes in the Sweepstakes. Entries will be deemed to have been submitted by the authorized email account holder. The authorized email account holder is defined as the natural person who is assigned to an email. You must enter using only an account registered in your name. The potential winner may be required to provide Administrator with proof that he/she is the authorized email account holder of the account associated with the winning Entry. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. Entrants may not create or enter with multiple accounts. Any entrant who attempts to enter with multiple accounts or under multiple identities will be disqualified and forfeits prize won, in Sponsor or Administrator’s sole discretion. Prize will be sent to address provided by winner after winner is verified and returns the completed Affidavit and Release. No PO boxes permitted. Unclaimed or returned prizes will not be awarded.
