

**Pink Whitney USA Jersey Sweepstakes
Official Rules**

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

The Pink Whitney USA Jersey Sweepstakes (the “Sweepstakes”) will commence at 12:00:00 AM Pacific Time (“PT”) on January 11, 2022 (“Start Date”) and end at 11:59:59 PM PT on March 31, 2022 (“End Date”). The period between the Start Date and End Date will be referred to as the (“Sweepstakes Period”). The Sweepstakes Period will be broken out into twelve (12) separate entry pools as set forth in Section 3 below (each, an “Entry Pool”).
